UPCOMING WEST TAMPA / WEST RIVER CHOICE NEIGHBORHOOD IMPLEMENTATION GRANT PUBLIC MEETING

The City of Tampa and the Tampa Housing Authority will host a public meeting on the upcoming application for a U.S. Department of Housing and Urban Development (HUD) Choice Neighborhood Implementation Grant for the West Tampa / West River community. This meeting will provide residents the opportunity to review the Transformation Plan for the community and learn how the grant will support the proposed activities before the application is submitted.

Staff from the City of Tampa, Tampa Housing Authority, and the West River design team will be in attendance to address any questions you may have. The meeting will include an overview of the planning process, the proposed physical plan, planned supportive services, neighborhood improvement projects, re-occupancy plans and economic opportunities for low and very-low income persons. This meeting is free and open to the public.

Whether you are still deciding where to relocate, or getting used to your new surroundings, please know that there are always resources for you and your family close by. If you have relocated too far from the familiar West Tampa Neighborhood Resource Center, Hillsborough County has four other resource centers located throughout the county:

The United Way Suncoast also operates the **Sulphur Springs Resource Center at 8412 North 12th Street**, **Tampa, FL 33604.** It is a place where adults can go for learning, to gain computer access, and engage in workforce development activities. The Resource Center offers programs and services including job training, financial counseling, benefit and legal assistance, education mentoring, classes, and workshops. Residents can use the computers, attend book clubs, take GED classes, and participate in leadership training and personal growth assistance.
