RELOCATION BEGINS

Tampa Housing Authority staff have been holding weekly relocation informational meetings for North Boulevard and Mary Bethune residents for several months. However, the relocation process was officially kicked off when the U.S. Department of Housing and Urban Development approved the Tampa Housing Authority's relocation plan for North Boulevard Homes and Mary Bethune High Rise on April 13, 2015. In April, regular mandatory relocation workshops started. And on May 20, 2015 the first households were offically cleared for relocation. Resident Relocation Familiarization Tours are held every Tuesday so that each resident can take a tour of all of the properties in Tampa Housing Authority's portfolio. Ms. Jewell Reed was the first person to move to a new apartment as part of the North Boulevard relocation.




